



# ( HEALTH AND WELL BEING

Elm House serves adults with developmental disabilities, mental illness and traumatic brain injuries. They are unable to attend activities we find normal and fun without someone taking them. We want to make sure that these individuals have access to the best nutrition and reduced intake of toxins. Caring about details takes work and many programs do not make the extra effort to address health issues. Serving processed food is easier then shopping for and



preparing whole foods. Adults with disabilities are at increased risk for abuse. They need others to watch out for risk factors and take the steps to insure safety.

Child Care Network through the Family Support Program. This program will serve highneed families from Monroe County; families that are low income (up to 250% of the Federal Poverty Level), experiencing homelessness, domestic violence, or another life crisis. Children receiving scholarships are birth-14yrs and need early learning, preschool, school-age before and after care, and summer care. Parents are primarily single women, but also include dual parent families, single male-headed households, and grandparents raising grandchildren. They are employed, attending college, participating in skilled trades, pursuing certifications, or participating in a job training/employment program.



## **EDUCATION**

Wagar Middle School \$15,000 support for a ROX, Ruling Our Experience, a program curriculum to equip girls with information and skills needed to live, healthy, independent, productive and violence-free lives. This program teaches understanding passive, aggressive communication, as well as how to use "I statements" as an important function of healthy communication. Girls are taught about their assertive rights, which is to understand that we all have



rights to stand up for ourselves and get our needs met. The girls also worked on team building activities and discussed empathy and how putting ourselves in other's shoes helps avoid conflict.



## 🕥 COMMUNITY ENRICHMENT

Sister Servants of IHM we offer support for non-violence training to participating schools during the 2019/2020 academic year. Violence has greatly impacted youth in our country, state and community. Students have become increasingly engaged around the issue of violence in schools since the Marjorie Stoneman Douglas High School shooting in February of 2018. They are eager



for their voices to be heard. In March of 2018, students from Monroe High School and St. Mary Catholic Central High School worked together to organize a "March for Our Lives" in Monroe, joining students across the country in speaking out about school shootings. Young people are continually "bombarded" with the logic and practice of emotional, verbal, physical, or structural violence. As a result, young people learn these falsehoods: human beings are intrinsically violent and the only way to deal with violence is to accommodate it, avoid it, or use it. This program promotes a deeper understanding and appreciation of the power of active non-violence


